District Goals

The Muscogee County School District will implement evidence-based Tier 1 instruction, a Multi-Tiered System of Support (MTSS), leadership development, and a culture of kindness.

School's Smart Goals

Smart Goal #1 100% of teachers will be trained on personalized learning and aligning task meeting the rigor of the standard with 85% implementing with fidelity by May 2020 as measured by walk through's and student artifacts and work samples.

Smart Goal #2 By May 2020, 100% of teachers will be trained and implement the Second Step curriculum to increase our attendance by 3%. (from 79.15 to 85.4).

WHAT IS TITLE I?

Brewer Elementary School is identified as a Title I school as part of the Every Student Succeeds Act (ESSA). Title I is a federal grant that was designed to ensure that all children receive a high quality education and reach grade level proficiency. Title I programs must be based on effective means of improving student achievement and include strategies to support parent and family engagement.

Title 1 Annual Parent Meeting

School Measures to Provide Required Assistance

- Conduct staff development on parent involvement practices and effective strategies for staff to communicate and build partnerships with parents.
- Partner with Head Start, Pre-K programs, daycares to share information about parent engagement activities that will help prepare parents and their child for kindergarten.
