School's Smart Goals

Smart Goal #1 By May 2019, 100% of staff will be trained in Tier 1 School-Wide Positive Behavioral Interventions and Supports (PBIS) and at least 5 out of 10 critical elements will be developed to 80% as measured by the Tiered Fidelity Inventory (TFI) and Self-Assessment Survey (SAS).

Smart Goal #2 By May 2019, 100% of teachers will be trained on strategies to help students process content through a differentiated approach with at least 80% effective implementation.

WHAT IS TITLE I?

Johnson Elementary is identified as a Title I school as part of the Every Student Succeeds Act (ESSA). Title I is a federal grant that was designed to ensure that all children receive a high quality education and reach grade level proficiency. Title

I programs must be based on effective means of improving student achievement and include strategies to support parent and family engagement.
